Architecture in the Absence of Pause

Architecture is complex. It consists of many intricate, inter-dependent layers, and it is only in an awareness of how these layers work together in relation to the world around us that a deeper and more sustainable understanding of its capacity and potential can be achieved. Untangling the demanding mesh of influences, tactics, and economic interests that thrive within architecture coupled with technology, is not just influencing how we perceive physical space, but also our expectations within physical space. Do the architectural and cultural challenges that have evolved out of this situation indicate new types of space and spatial sequences, and will these be accessible to all members of society? What is the human behaviour in relation to this new type of configuration?

Architecture as a public commitment with a clear social consciousness is increasingly difficult to define, let alone realize. What is life behind the architectural mask, behind the visual edifice with all its projected amenities, and is it what we think it is?

Per Olaf Fjeld is a professor at the Oslo School of Architecture and Design. He was educated in the USA, and took his master degree under Louis I Kahn at the University of Pennsylvania. He later returned to this university to do research under a Fulbright – Hays grant. Fjeld has written a number of books and articles on architecture. His first international work was “Sverre Fehn, The Thought of Construction” Rizzoli, 1983. His latest book entitled Sverre Fehn, The Pattern of Thoughts was released by Monacelli Press in June 2009.

Fjeld has lectured and served on juries throughout the world, and has been a guest professor at Cornell University and the University of Arizona. In 2005 he was elected President of the European Association of Architectural Education and in 2011 he received an honorary professorship at the Royal Academy of Architecture and Design in Copenhagen. Fjeld has run a small architectural studio with his wife Emily Randall Fjeld since 1975.
